

OBJECTIVE

This is a multi-asset high equity mandate which aims to create long term wealth for investors while protecting capital over the medium term. The maximum net equity exposure of the fund is 75% and it may use index derivative contracts to reduce net equity exposure. The mandate may invest up to 30% offshore.

INVESTMENT MANDATE

The mandate invests in a combination of equities, commodities, listed property, preference shares and fixed income instruments. It may invest internationally. The mandate employs an active asset allocation and securities selection strategy and may use derivatives to reduce net equity exposure when appropriate.

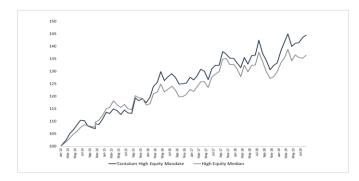

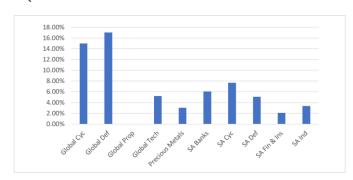
